- Every member of the State Association / UT/ Unit who is in the good standing in accordance of Memorandum of Association and Byelaws of Indian ICESTOCKSPORTS Federation, enlisted in the Electoral College to participate in the elections. State ICESTOCKSPORTS Association-02 (Two); Union Territory-02 (Two), representative each shall be entitled.
